

How did we get here???

It's been a long road! Here's a brief reminder of what got us to where we are today

- July 2019: City of Chicopee hires HW
- August 2019: Kick off engagement and survey at the Downtown Get Down
- November 2019: Kick off Steering Committee meeting
- January February 2020: Preparing for first round of public workshops, building off data from the Baseline Report
- March 2020: We took a little . . . pause and redirected



How did we get here???

- June 2020: Steering Committee had its first virtual meeting – shift to virtual public engagement
- Summer 2020: Preparation of Key Takeaways to present to the public
- September 2020: Virtual Public Workshops
- Fall 2020: Virtual Open House and Meetings-in-a-Box —
 Developing "themes" and a structure for the Plan
 based on community feedback
- January June 2021: Drafting the Plan Online and hard copy surveys, over 1,000 responses!
- June September 2021: Review by City staff and Steering Committee refining of action items

How did we get here???

- Fall 2021 Spring 2022: Formatting of Plan
- Fall 2022: Preparation of Action Plan
- Spring 2023: Review of Action Plan by supporters

What Happens Next?

We're very close to getting this over the finish line!

- July 13: Plan reviewed by the Planning Board
- TBD: Public hearing and adoption
- TBD: Endorsement of the City Council

Ongoing hard work every day to make sure the plan is implemented and updated as needed over the next 10-20 years

This is the only major piece of the plan the Steering Committee has yet to review and comment on.

Implementation

The Action Plan opens with a framework for implementation. Make sure things get done!

Some things can happen right away – others may take a decade or more to implement.

City can consider adopting all or parts of this framework into its Code Of Ordinances, for extra weight.

Implementation Committee

- Established and appointed by Mayor/City Council
- Coordinates and monitors implementation of the Plan
- Meet at least twice a year
- Be empowered to track progress of all Plan actions
- Reach out to all "Champions" for annual progress updates
- Compile all updates into an Annual Progress Report, including:
 - ✓ Major successes
 - ✓ Barriers to implementation
 - ✓ Justification for any inconsistencies
 - ✓ Specific actions for the coming year
 - ✓ Recommendations for future plan edits, if needed

Champions

Includes City department heads or their designees, the Mayor's Office, City Council, City boards and commissions, and possibly non-governmental entities such as non-profit organizations and private citizen groups.

- Report out each year on the actions they are responsible for
- Government entities should be required by ordinance to complete this annual report out
- Responsible for getting updates from "Supporters" and "Community Partners" identified in the Action Plan

Planning Board

- Planning Board is the Champion for many actions
- Set aside at least 2 hours every four months to work on these actions
- Planning Board should have the authority to request updates from any other Champion or Supporter

Mayor's Office

- Responsible for holding the Implementation Committee accountable for its responsibilities
- May request further information or explanation from the Committee

Communications and Transparency

- Annual Report should be posted on the City's website
- Advertised broadly through the Mayor's Office
- Contact information for each Champion should be provided
- Chicopee residents are welcome to reach out with any questions, or to express an interest in volunteering to help implement any action
- Share copies of the report annually with all neighboring municipalities

Education

Making sure City staff, volunteers, and elected officials are aware of the Plan

- Every City facility or department should maintain a hard copy of the Plan for staff reference.
- Each new member of any City board or commission, local elected official, and City staff should take a brief tutorial on the Plan given by Planning Staff and the Implementation Committee.

Getting it Done – A Recap

Develop a process for Plan implementation that ensures Envision Our Chicopee: 2040 is referred to in all City decision making and that champions are held accountable for furthering the action(s) for which they are responsible

- Develop and officially adopt a system for multiple people and groups to monitor implementation progress of the Plan.
- Reserve meeting time each year for the Planning Board to focus on Plan implementation and encourage other champions to do the same.
- Develop a system for ensuring that all City staff, volunteer board and committee members, and elected officials are educated on the content of the Plan and how to use it.
- Develop a public communications strategy to ensure the general public knows where to find information on Plan implementation or to volunteer to help.

Funding

- Almost every action requires some level of funding.
- The Plan does NOT serve as a budget for the City.
- It is not sustainable to overly rely on federal funding for ongoing expenses.
- It is not sustainable to overly rely on property taxes.
- Bonding is a valid way to invest in things, but it adds to the debt burden and cannot be overly relied upon.

So what do we do?

- Explore new and more locally driven sources, large and small.
- Everything should be on the table, from tax reform to public-private partnerships.

Our leaders should approach the City's budget with clear goals, data, accountability, innovation, and equity

Action Matrix

- All actions listed per Chapter.
- A Champion is listed for each action the lead agency responsible for implementation of an action.
- Up to three Supporters listed other agencies that will be critical in assisting with implementation of an action.
- Some actions list Community Partners Organizations outside of City government who may play a role in assisting with implementation of an action.

Each action is marked with a *Priority Level* of *Highest – High – Medium – or- Lesser*

These are all the same Actions the Steering Committee has already reviewed, with a handful of edits from City staff
